In terms of Resolution No. 6.1

6.1 MOHOKARE LOCAL MUNICIPALITY BUDGET FOR THE FINANCIAL YEAR 2014/15

It was indicated that Consultations were made in all three towns of Mohokare and all people who are working were encouraged to pay their Municipal accounts and those who are not working were requested to register as indigents as the municipality will assist only formally registered indigent households.
