<b>Business Licenses</b>				
In addition to business registration, certain businesses are required to get a business licence in terms of the Businesses Act. A business licence is generally required for businesses that need to comply with health and safety regulations. Licences are required for the following businesses:				
- making or selling food which can go off				
- health or entertainment activities (including businesses offering saunas, massages, snooker, billiards, slot machines, night clubs, and cinemas).				
Traders do not have to apply for a new licence every year.				
They do have to apply for a new licence:				
- if they move their business to other premises				
- if they sell the business, the new owner will have to apply for a licence
