Only enterprises who satisfy the criteria stated in the Tender Data may submit tender offers.

The Preferential Procurement Policy Framework (Act No.5 of 2000) utilizing 90/10 preferential point system allocation will apply and a certified and valid B-BBEE Status level Verification Certificate must be submitted.

Tenderers should note the following: Tenderers who are listed in the National Treasury Register of Defaulters will automatically be disqualified, it is compulsory to complete all the SBD forms, which are attached as returnable documents.
