The server room must conform to industry standards for securing information systems hosted in the server room.

At the minimum, the server room should provide for:

1. Efficient Cooling system
2. Secure Server entrance and monitoring
3. Minimize fire risk, water-flood risk
4. Continuous monitoring and alerting system when disaster happens
5. Proper electrification (Surge protection)



The above list is indicative, and is by no means exhaustive or at limit.

**Compulsory Documentation** to be attached to Quotation, failure to submit valid documents as specified below will invalidate the offer.

**Please deposit Quotation in the Quotation box situated at the Municipal Offices.**

All Quotations **must be** submitted on your Companies official documentation **with letterhead** alternatively the Quotation must be stamped with your Companies official stamp.

Failure to comply with the above **will invalidate** the Quotation.

**Attach all required compulsory documentation e.g. Tax Clearance, declaration of interest (obtainable from the Municipality's website) and BBEE certificate, failure to do so will result in an automatic disqualification.**

**NB:** The following shall not be considered:-

- (a) Quotations received after the closing date and time determined here-in.
- (b) Quotations of which the envelopes have not been duly marked for identification.
- (c) Telegraphic, faxed and telephonic tenders or those completed in pencil.
