### **DRYWALL SPECIFICATION**

Beta® 76mm Drywall Partition System comprising natural anodised aluminium ceiling channel, 52mm Ultrasteel floor track and 51mm Ultrasteel vertical studs at 600mm centres, friction fitted, or riveted to ceiling channel and floor tracks with similar additional vertical studs as necessary at corners, ends etc, and covered both sides with 12,5mm Gypsum Tapered Edge Wallboard screwed to studding with 25mm drywall screws at maximum 220mm centres. Boards butt joined and tapered edges fitted with 50mm wide self-adhesive Fibatape and finishes with Rhinoglide jointing compound all in accordance with the manufacturers instructions.
