Tenderers should have a CIDB grading of 7CEPE or 8CE or higher, Regulation 25(8) will apply for potentially emerging (PE) contractors who satisfy the criteria stated in the tender data.

Tenders shall be evaluated using the functionality criteria comprising of the following:

**The appointed contractor will be expected to subcontract a portion of the works to the local SMME's.**

The **80/20 (price 80 & B-BBEEE status level contribution 20)** Preference points system will be used.
