- 1.9 **"Bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods, work or services.
- 1.10 **"Comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilised have been taken into consideration
- 1.11 "Consortium or joint venture" means as association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of a contract.
- 1.12 "Contract" means the agreement that results from the acceptance of a bid by an organ of state.

# REQUIREMENTS

The Pound master is expected to have the following:

- Sound knowledge of animals Pound By-laws of Mohokare local municipality.
- According to the Animal Identification Act.202 (act no 6 of 2002) and Pound
  Ordinace,1952 (Ordinance 18 of 1952 as amended), the Pound master must have the
  ability to handle animals, ability to identify different sicknesses in the animals and
  quarantine of such animals.
- Ability to liaise with state vet in all aspects of animals in the pound.
- A driver's license.
- A clean criminal record

### **KEY PERFOMENCE AREAS:**

Receiving of all animals including those straying by the pound master, and register them on the pound register.

Issuing of receipt for impounded animals on release.

Ensure separate number of enclosure for different animals as per municipal by-laws Ensure destruction of sick and dangerous or contagious animals as per the Animal Act Ensure well-being of the animal by feeding and treating any sick animals Issuing of notice of impounded animals to the community

Keep pound register and ensure availability of the animal register for inspection, free of charge to any authorized officer or official of the municipality, State Vet, and SAPS. submission of pound register entries to municipality after pound sales within 14 days. adhere to fees as determined by municipal council, ensure notice of sales, arrange for auctioneer. Pound master must ensure that animals are properly fed and kept in safe and clean environment.

### FUNCTIONS AND DUTIES OF POUND KEEPERS

A pound keeper must keep a proper record of every animal impounded which must include the details of the location where the animal was found, identification mark, contact details of the person who impounded the animal, the time and date the animal was found and impounded.

Where an impounded animal has caused damage to property, the pound keeper must record the occurrence and the extent of the damage caused by the animal.
