1.10 **“Contract”** means the agreement that results from the acceptance of a bid by an organ of state.

1.11 **“Specific contract participation goals”** means the goals as stipulated in the Preferential Procurement Regulation 2017. In addition to above-mentioned goals, the Regulations [12. The scope of the project entails the Electrification of 200 Households at Smithfield on a Turnkey Approach not limited to but inclusive the following:

1. Conduct thorough investigation/study of site, including the existing infrastructure services
2. Liaise with Eskom for Energizing, this includes electrical applications and direct payments of Eskom invoices using Municipal credentials
3. Design, facilitate proposal, construct and monitor implementation of the project
4. Provide a preliminary estimate on the electrical network of development and population growth based on available demographic information
5. Liaise with the community/stakeholders through the ward councillor and the project CLO for the implementation of the project from commencement to completion
6. Provide an offered cost for the project
7. Provide an anticipated technical energy loss for the purpose of energy balancing
8. Construction of electrical reticulation network, PLC prepaid electricity meters' connections for households in Smithfield
9. Provision of transformers
